1. Introduction

1.1. Invitation to Bid

SAHAS Nepal is one of the leading national NGOs, established in 1996 with focusing its efforts among vulnerable families and rural communities who are socially excluded and deprived of opportunity. SAHAS Nepal is implementing "Marginalized No More" project in partnership with Street Child. We are planning to procure goods required for the MNM Project. Therefore, we invite your company/firm to submit a bid for given different livelihood and enterprises related materials based on the specifications, requirements and terms and condition set forth in this Bid document. This Bid intends to enable SAHAS Nepal to identify qualified suppliers for the supply of above mentioned materials. The Bid describes our current understanding of our needs however these needs and specifications can be changed if SAHAS Nepal feel necessary.

1.2. Summary of Bid

The objective of the Bid is to enter into an agreement with suppliers for provision of Livelihood and Enterprises related materials items. This award will be conditional on the ability of suppliers to provide goods that meet SAHAS Nepal standard specification (as attached) in accordance with the delivery schedule.

Although the successful bidder may become the dedicated supplier, this agreement will not constitute an exclusive contract. In the event that any supplier cannot meet the agreed delivery schedule, another supplier shall be sought by SAHAS Nepal for the particular purchase to ensure that the needs of SAHAS Nepal are met.

2. Instructions for intending to respond and submitting of Bids

- 1. Bidder must submit the bid document with organization stamp and authorized signature in **each pages**.
- 2. Bidder must quote the price for **all** the material otherwise the SAHAS Nepal reserve right to reject the bid document.
- 3. Bidder must fill the rate in the Bid form **clearly both** in figure and words and if there is any variation in figure and words, the rate written in words will be valid one.
- 4. Sealed Bids must be submitted to the email address of SAHAS Nepal on or before 5:00 PM on 2021/02/21. Documents received after this deadline shall not be accepted.
- 5. Bids shall be opened in the presence of Bidders' representatives (not compulsory) who choose to attend at 01:00 PM on 2021/02/23 at the office of SAHAS Nepal, Sanepa, Lalitpur. Any change in the date shall be notified.

- 6. Bids must be valid for a period of 45 days counting from the day of bid opening and Bidder shall deposit 2.5 % cash or bank guarantee at the time of bid document submission and bidder awarded contract shall deposit 2.5% of contract amount as security in the bank account of SAHAS Nepal before conclusion of the procurement contract.
- 7. Bidder awarded contract must provide materials at their own cost to SAHAS Nepal, **Dhanusha** (**Janakpur**), **Mahottari** (**Bardibas**), **Siraha** (**Golbazar**) and **Saptari** (**Rajbiraj**) and **Sunsari** (**Itahari**) districts. SAHAS Nepal will not be responsible for any damage or losses during transportation. Verification will be done by SAHAS Nepal staff before the materials are dispatched and after receiving.

3.3. Timing

Material must be delivered within <u>15 days of issuing Purchase Order</u>. Time is of the Essence; therefore, if the delivery of the goods is later than the stipulated time, a penalty 2.5 % of PO may be charged. The penalty will be deducted at the time of payment. (Special case will be consider)

3.4. Pricing and Pricing Methodology

- 1. All prices quoted must remain valid and available for acceptance by SAHAS Nepal for 45 days,
- 2. All prices quoted must be mention including VAT or not. If not mentioned it is assumed as including VAT,
- 3. All prices quoted must be mention including packing cost. If not mentioned it is assumed as including packing cost,
- 4. Transportation cost to be charged for delivery of goods to deliverable site must be mentioned separately, If not mentioned it is assumed as including transportation cost,
- 5. Undisputed invoices shall be paid within thirty (30) days from the date of receipt of the original invoice and goods after delivery.
- 6. Payment shall be in NPR and Payment will happen via account payee cheque.

4. EVALUATION

4.1. Evaluation Criteria

SAHAS Nepal will evaluate the submitted Bid forms and select a Supplier, at its absolute discretion.

Criteria that may be used includes but is not limited to the following, in no particular order:

- 1. Product quality, reputation and performance.
- 2. Thoroughness of Bid preparation.
- 3. Capability of the supplier to deliver the material by the required dates
- 4. Competitive price offered by bidder.
- 5. Sample verification.
- 6. Flexibility of Suppliers.
- 7. Acceptance of terms and conditions of SAHAS Nepal.
- 8. Reliable delivery methods.
- 9. Proven performance and experiences.

4.2. Grounds for disqualification of Bid

Bidders will be excluded from participation in a bidding process if:

1. They are bankrupt or being wound up, are having their affairs administered by the courts, have entered into an arrangement with creditors, have suspended business activities, are the subject of proceedings concerning those matters, or are in any analogous situation arising from a similar procedure provided for in national legislation or regulations.

- 2. They have been guilty of professional misconduct proven by any means which SAHAS Nepal can justify.
- 3. During the course of contract, if it is found that any child labor and/or child are being exploited, abused, and sexually harassed; the contract shall be terminated immediately. SAHAS Nepal will not be responsible for any loss occurs if it is found guilty.
